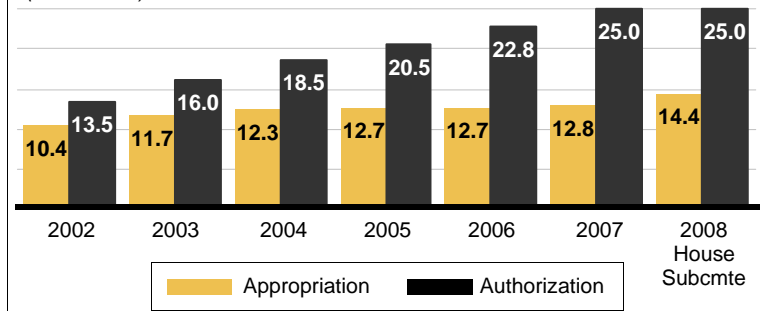

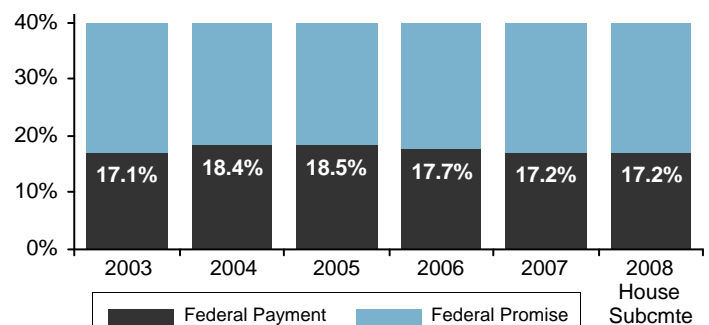

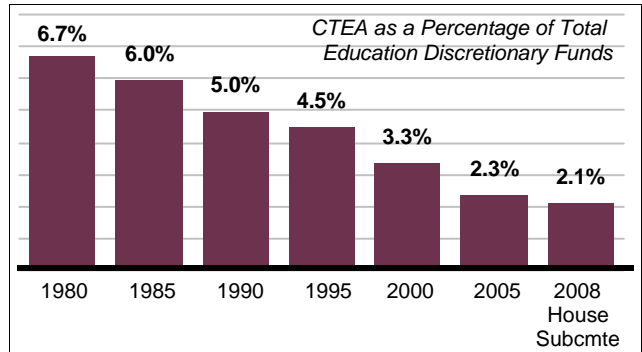
Federal Payment vs. Federal Promise\*

(\*40 percent of the excess costs of educating children with disabilities)



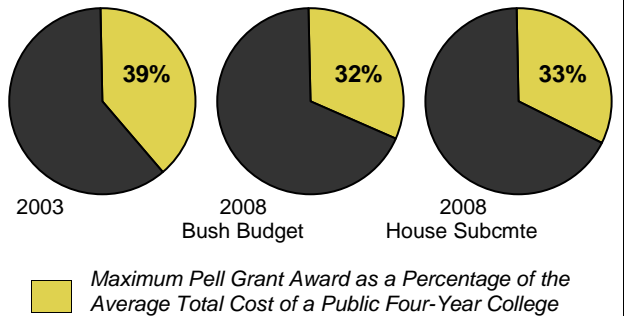

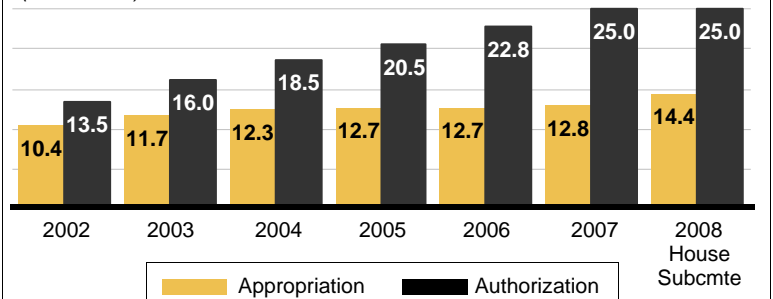

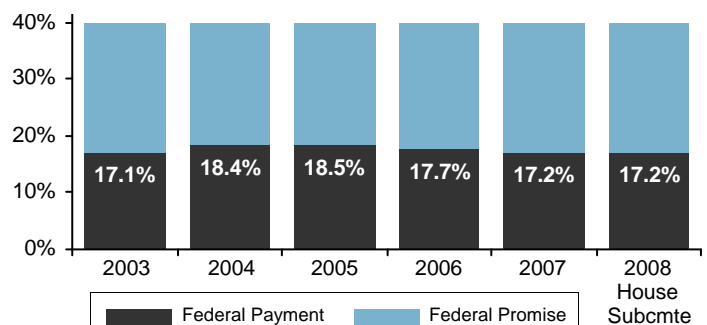

(\*40 percent of the excess costs of educating children with disabilities)



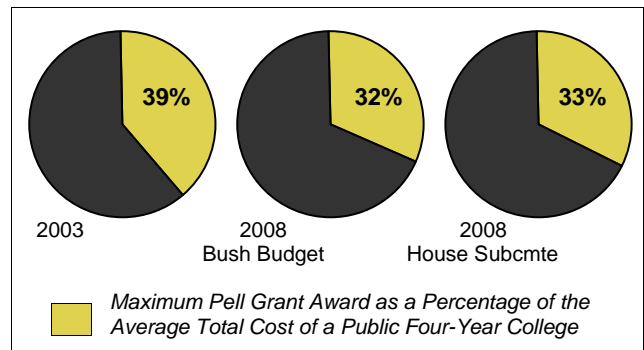

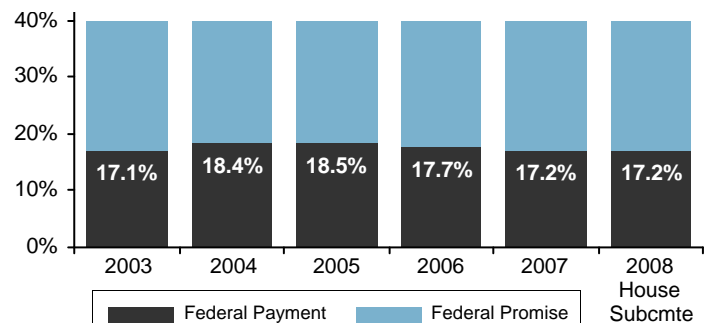

Federal Payment vs. Federal Promise\*

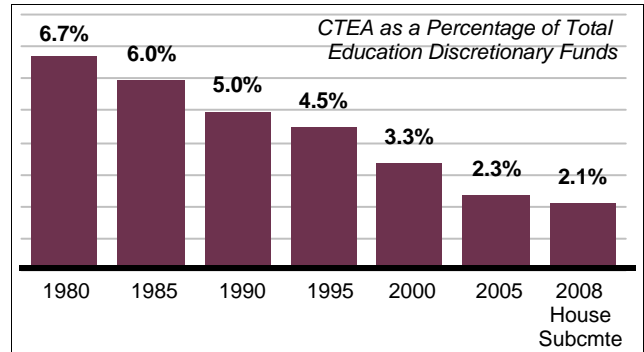

**Education Appropriations, House Subcommittee Mark**
