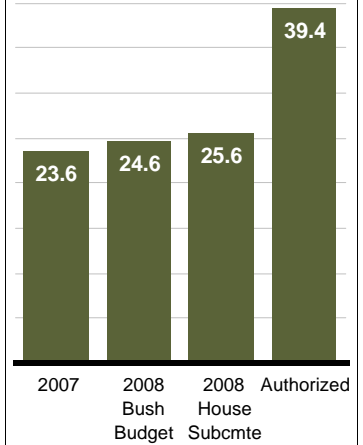

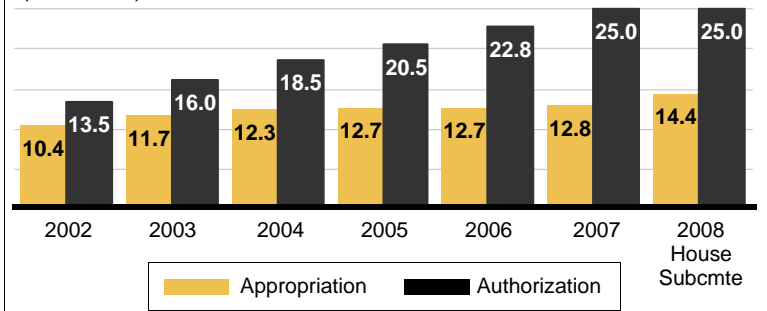
(\$ in billions)

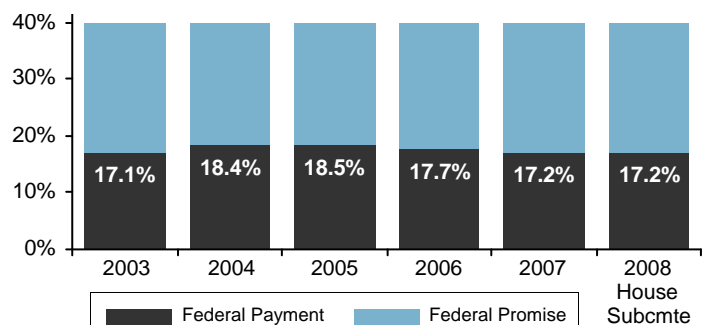

Federal Payment vs. Federal Promise\*

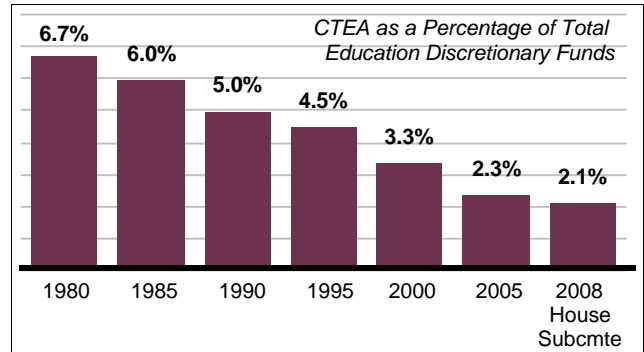
