PRESIDENT'S MESSAGE: *FORMIDABLE TIMES AHEAD!*

Despite a tough fiscal landscape within NEA and an unprecedented loss of membership resulting in \$17 million cuts in the proposed NEA budget, the newly minted NEA Office of Higher Education is working to foster a team model to meet the challenges of day-to-day operations. The recently ratified Higher Education Strategic Organizing plan is in the process of being converted to an action plan.

Our higher education conference in Boston was very successful. We tackled many of the challenges, including the role of technology in the classroom, the role of private sector philanthropy, outcome and assessment measures, contingent worker growth and decline of full time positions, growth of the for profit industry and impact of the gainful employment regulations on students..

The national scene continues an unprecedented attack on American labor and in particular on education unions and employees. In addition to legislative threats to eliminate bargaining rights, we experience coordinated attacks with vouchers, charter schools, tenure and seniority, alternative certification, teacher evaluation and freedom of speech.

This year's RA offers tools for the opportunities ahead. Next year is an election year. This is an unparalleled opportunity to prepare our members for activism and engagement.

This summer, the NCHE will have its retreat. Once again, higher education has much on its plate as we continue our work on the for-profit moratorium, increased organizing efforts, working with the new Office of Higher Education structure, and confronting the dangers lurking at what seems to be every corner, trying to negate our rights and our worth.

I look forward to seeing all the higher education delegates at our NCHE meetings beginning on June 30.

CONGRATULATIONS: ADJUNCTS WIN UNION VOTE AT EAST-WEST U.

Adjunct faculty members at East-West University, in Chicago, voted to unionize and to be represented by a chapter of the National Education Association. The vote follows numerous disputes in which the organizers accused the University of eliminating adjunct jobs to avoid a vote. The university released a statement after the vote in which it said: "All faculty and staff should be aware that this election will not affect anyone. Nor will this affect the current operations of the university. Although the university will bargain in good faith with the union representatives, this does not change our mission focusing on excellence and service. *Inside Higher Education*

We expect a very active RA in Chicago. As NEA grapples with a loss in membership, a dramatically scaled-back, a second-year budget, a proposed bylaw amendment to increase contributions to the Ballot and Legislative Initiative Fund by \$10 for five years, a policy proposal around accountability, and, probably biggest of all, a proposal to endorse President Obama at this year's RA, delegates can expect lively caucus meetings and, no doubt, livelier floor debate.

Higher education will also have two at-large vacancies to fill, along with at large ESPs and an administrator, all to be elected by the RA delegates. We will also be working hard to renew NCHE memberships.

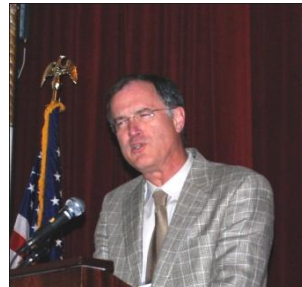
