PRESIDENT'S MESSAGE: YIKES!

We are little more than a year out from the 2012 elections. "Occupy Wall Street," "Tea Party," "Rick Perry," "Global Collapse," "Obama Care" are only a sampling of the rhetoric of our day. We have a long way to go in time and perception. There will be many more legitimate surprises and more outrageous and inflammatory rhetoric in the coming year. I urge you to stay focused. Do not conclude that the current political situation is hopeless; do not conclude all is lost. Despite the current congressional dysfunction, reality continues. Most importantly, the reality a year from January is interesting in its potential. Choosing to do nothing, although still an action, is not where we can collectively afford to be. Stay informed and stay active!

CAUTION, CASH, AND THE COMMUNITY COLLEGES

NCHE has at least three targets to monitor within the NEA.

- The National Governors Association released a report as part of the Complete to Compete initiative that urges states to increase their capacity to graduate students and produce workers, produce outcome measures, and allocate state funds based on these outcomes.
- Arne Duncan, Secretary of Education, plans to fold the \$110 million into the TEACH Grant Program to a proposed \$185 million Presidential Teaching Fellows Program with new outcomes and performance measures. <http://www.2ed.gov/inits/ed/index/htm>
- The US Department of Labor in partnership with the US Department of Education under the Trade Adjustment Assistance Community College and Career Training Grant Program is promoting training to eligible low-skill workers requiring improved retention and completion rates, reducing time to completion for degrees and certificates, meeting industry needs, developing career pathways and using technology to improve learning.

All three of these policy initiatives contain money, programs, and challenges. The devil is in the details. Check NEA's Websites for its talking points and the FAQs for the Presidential Teaching Fellows Program. Please let us know what is going on in your state.

OHIO AND NEA ROLL OUT HUGE VICTORY

It was an exciting night for the OEA and its members. By a 61-39 percent margin, the ballot initiative failed Ohio. *We are Ohio*, a citizen-driven, community-based, bipartisan coalition stopped Senate Bill 5. OEA/NEA members played a critical role--pounding the streets, knocking on doors, and phone banking their way to repeal of SB5. NEA deployed 177 staff members and resources from 22 states. The OEA, NEA's state affiliate, fielded the largest number of volunteers of any group or organization working on the campaign--one out of every four volunteers who hit the streets to campaign against Issue 2 belonged to the Ohio Education Association.

EDUCATION INTERNATIONAL, 6TH WORLD CONFERENCE, CAPE TOWN, SOUTH AFRICA

NEA higher education was represented by Jim Rice, NCHE President, Gilda Bloom-Leiva, Leslie Richards, Ann Shadwick, Stan West, Maury Koffman, and Mary Hatwood Futrell. Two measures important to higher education faculty and staff were considered: increased monitoring of new international copyright agreements, which tend to restrict faculty access to materials for teaching or research, and a comprehensive education policy to guide the views of its 30-million strong global membership was approved. This policy is supported by the belief that quality public education is essential for healthy communities and must become a global priority for all governments. 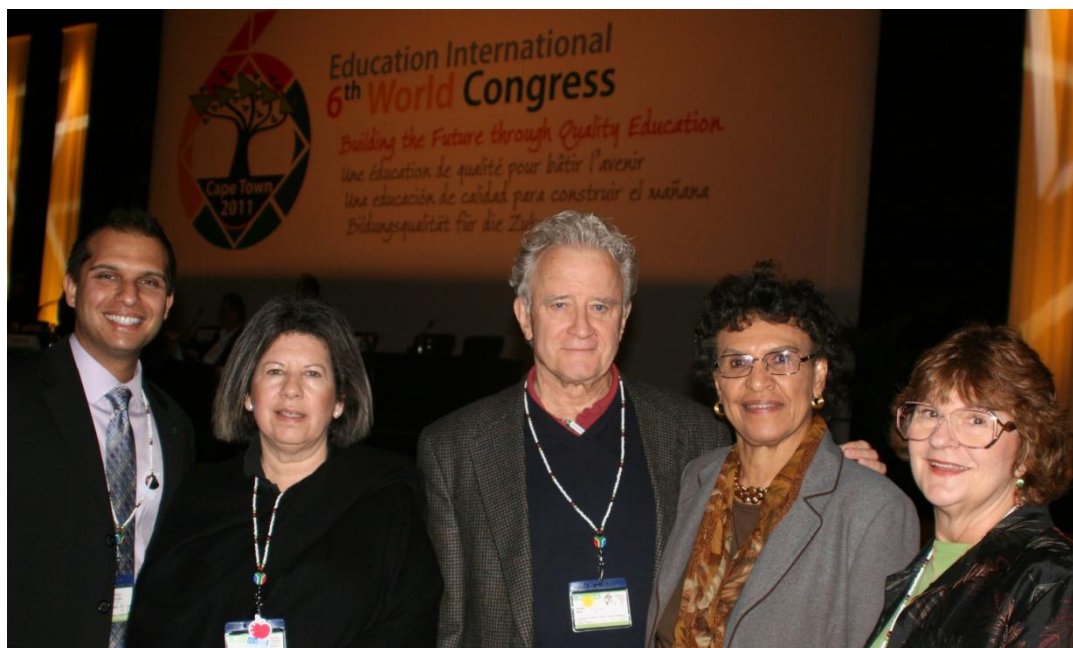
The Higher Education Caucus provided updates from countries on a wide range of topics and policies: governmental defunding of public higher education, restricting student support thereby restricting access, minimizing higher education as a public good and substituting higher education as a lightly regulated private market in which the consumer demands dictates. Congress delegates were anxious to hear about the United States particularly Wisconsin and Ohio, and they generally perceived dysfunction of our government system.

The afternoon session was focused on the casualization of the profession mainly by limiting tenured positions thereby blocking adjuncts from an upward career path and creating a growing body

of fixed term workers subject to low wages and no benefits. EI was requested to address this problem.

Other items discussed were: loss of professional autonomy and concentration of authority vested in the hands of administrators; increased accountability requirements; attacks on academic freedom and civil liberties; and assaults on collective bargaining and union organizing.

The 7th World Congress will be in the summer of 2015.
