Categories

On the entry form, choose one of the following categories for each print publication submitted.

- > Established State Retired Newsletter (published three or more years)
- State Retired Newsletter (published fewer than three years)
- Established Local Retired Newsletter
- NEA-Retired Spotlight Award (State Active Newsletter Covering Retired Issues)
- > E-Newsletter (Electronic newsletter)

Entries must be postmarked by April 15 of the year for submission. Please complete the entry form and include three (3) copies of it with at least two (2) – and if possible, three (3) - copies of different issues of your newsletter from the submission year.

Newsletters should exhibit good journalism and show broad and effective coverage of issues relevant to members (e.g. COLAs, insurance, health care, pensions, community service). Newsletters should be well written with visually appealing content, offer a combination of organizational and consumer-oriented information, showcase the members and leaders, and act as an effective organizing tool.

A newsletter that has earned the NEA-Retired Newsletter Award three (3) times in the same category becomes a member of the **NEA-Retired Hall of Fame**. The years do not have to be consecutive. Recipients of Hall of Fame recognition are not eligible to enter in the <u>same category</u> for three (3) years following the date of inclusion in the Hall of Fame.
