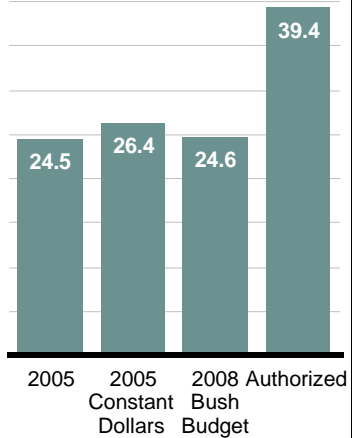
President Bush's Education Budget

- Cuts funding for the U.S. Department of Education by almost \$1.5 billion, or 2.6 percent, compared to 2007; and is below the level funded in 2006.
- Eliminates funding for 44 programs for a reduction of \$2.25 billion, including educational technology state grants, school counseling programs, and dropout prevention programs.
- Cuts funding for public elementary and secondary schools (based on the combined totals for NCLB Act programs, IDEA programs, and career and technical education), while private schools would receive \$300 million.

Proposed Funding for No Child Left Behind (NCLB)

- A net \$993 million increase for a total of \$24.6 billion, but is offset by cuts to other education programs. Net increase includes \$300 million for two new private school voucher programs. Excluding these voucher proposals, funding increases by 2.9 percent.
- Funding gap: \$14.8 billion (2008 Bush budget compared to what is promised in the law in 2007, the last year of authorization). The seven-year shortfall between authorized levels and actual funding grows to \$70.9 billion.
- Returns support to about the 2005 level, but is still \$1.76 billion less than what would be necessary to keep up with rising prices.
- Cuts Improving Teacher Quality State Grants by \$100 million and Safe and Drug-Free Schools and Communities State Grants by \$250 million. Most other programs are frozen at the prior year's level.

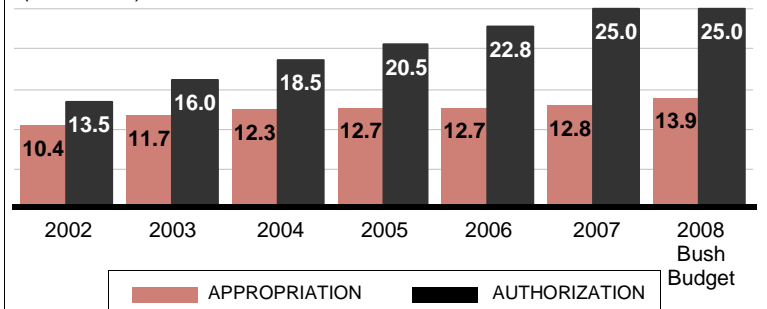

Grants to Local Educational Agencies (ESEA I-A)

- Increases funding by \$1.1 billion, which is directed toward high schools.
- Despite the increase, the 2008 Bush budget still falls \$11.1 billion short of last year's authorized level (programs under NCLB are authorized only through fiscal year 2007); and the cumulative shortfall since enactment would rise to \$54.7 billion.

(\$ in billions)

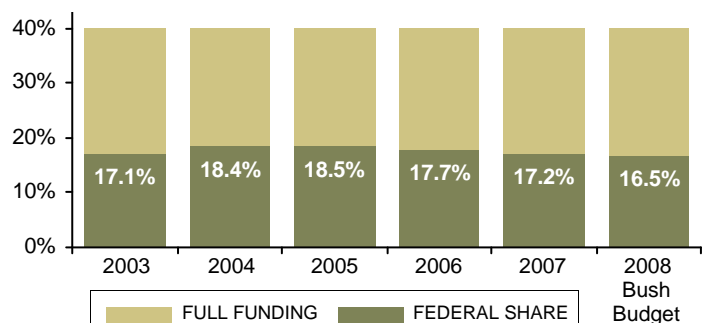


Special Education Grants to States (IDEA)

- Cuts funding by almost \$300 million from 2007.
- Funding gap: \$8.7 billion (2008 Bush budget compared to 2008 authorization).
- Represents only 16.5 percent of the federal share of educating children with disabilities, which is the lowest level of federal support since 2002; and continues the slide from the peak level of 2005.

Federal Share vs. Full Funding*

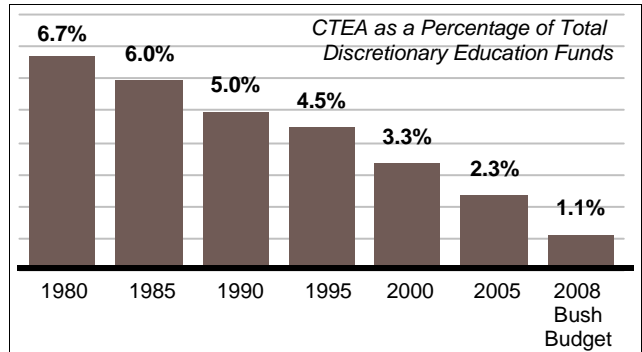

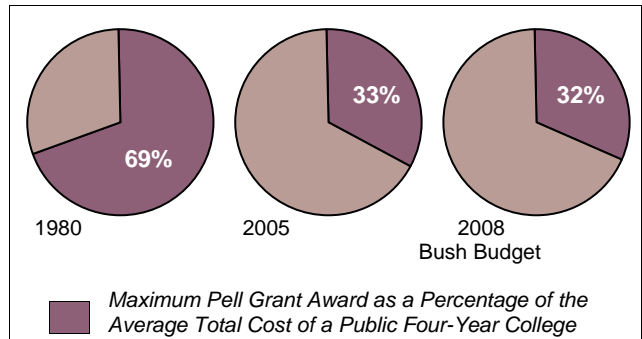

- ### Career and Technical Education (CTEA)
- Cuts funding by \$686 million, or 53 percent, including no proposed funding for Tech-Prep Education State Grants.
 - Continues a downward march in support for career and technical education from a high of 6.7 percent of total discretionary education dollars in 1980 to just over one percent in 2008.



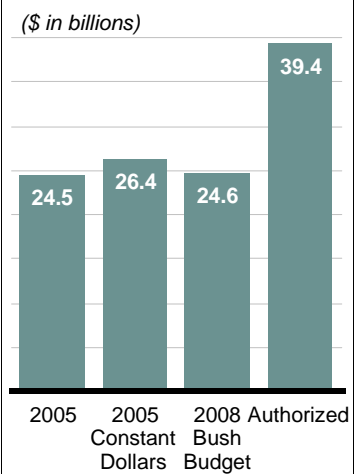
- ### Federal Pell Grants (HEA)
- Increases the maximum Federal Pell Grant award by \$290 to \$4,600 in 2008, and in \$200 increments annually to reach \$5,400 by 2012.
 - From 2003 to 2006, the maximum Pell Grant award was frozen at \$4,050 while the cost of higher education shot up 22 percent. Even with the proposed increase, the maximum award's share of the average total costs of attending a public four-year college declines to under 32 percent from 33 percent in 2005, and is less than half of what it was in 1980.
 - Proposes to pay for the increase by cutting other student aid, such as eliminating Federal Supplemental Educational Opportunity Grants, and holding Federal Work-Study steady at the same level funded the past two years.
