

## **Current Bylaws With Corresponding Proposed Bylaws Amendments**

### **2021 NEA-Retired Annual Meeting**

#### **Article III, F – Current**

- F. Become involved in the election of pro-education candidates to public office and lobby for educational measures in conjunction with policy decisions made by the NEA and its affiliates; and

#### **Article III F – Proposed**

- F. Become involved in the election of pro-public education candidates to public office and advocate for educational measures in conjunction with policy decisions made by the NEA and its affiliates; and

#### **Article III G – Current**

- G. Assist the NEA in the improvement of instruction and the advancement of the image of teaching in America.

#### **Article III G – Proposed**

- G. Support the NEA in the improvement and the advancement of public education in America.

#### **Article VII, Section 4, B Duties – Current**

The Secretary shall be responsible for keeping the minutes of all meetings of the NEA-Retired Executive Council and the NEA-Retired Annual Meeting. He/she shall present for adoption at the subsequent meeting of each of these two governing bodies, the respective minutes of the previous meeting. He/she shall also be responsible for maintaining the historical records of the organization.

#### **Article VII, Section 4, B Duties – Proposed**

The Secretary shall be responsible for keeping the minutes of all meetings of the NEA-Retired Executive Council and the NEA-Retired Annual Meeting. They shall present for adoption, at the subsequent meeting of each of these two governing bodies, the respective minutes of the previous meeting. They shall also be responsible for maintaining the historical records of the organization. The Secretary is also responsible for maintaining a directory of state affiliate leaders.

### **Article XI, Section 3 Eligibility – Current**

Only Retired delegates to the NEA Representative Assembly shall be eligible to be elected to the NEA Resolutions Committee.

### **Article XI, Section 3 Eligibility – Proposed**

Only Retired delegates to the NEA Representative Assembly shall be eligible to be elected to the NEA Resolutions Committee as Retired members or as Alternate Retired members.

### **Article XII, Section 4 Meeting Participation – Current**

NEA-Retired members who are not delegates to the NEA Representative Assembly and Pre-Retired subscribers will be treated as observers without the right to vote but may otherwise participate in the proceedings according to Robert’s Rules of Order Revised.

### **Article XII, Section 4 Meeting Participation– Proposed**

NEA-Retired members who are not delegates to the NEA Representative Assembly and Pre-Retired subscribers cannot vote, make, or second motions but may otherwise participate in the proceedings.

### **Article XIII, Section 2 Deadline for Submission – Current**

Deadline for Submission - For consideration at the NEA-Retired Annual Meeting, proposed amendments to the NEA-Retired Bylaws must be submitted in writing to the NEA-Retired Executive Council before its May meeting.

### **Article XIII, Section 2 Deadline for Submission – Proposed**

For consideration at the NEA-Retired Annual Meeting, proposed amendments to the NEA-Retired Bylaws must be submitted in writing, on the appropriate form, to the NEA-Retired Executive Council before its May meeting. All proposed amendments to the Bylaws shall be sent to the delegates to the NEA-Retired Annual Meeting at least two weeks prior to the meeting.

### **Article XIV Parliamentary Authority (New) - Proposed**

The current edition of Robert’s Rules of Order Newly Revised shall be the authority in all matters of procedure at the Annual Meeting, except as otherwise specified in the governing documents of the National Education Association and these Bylaws.
