

PURPOSE

NEA Board of Directors created the Friend of Education Award as an annual recognition of a person, organization or group whose leadership, acts, and support have contributed to the improvement of American education on a national level. Past recipients include U.S. Presidents, a Secretary of the U.S. Department of Education, a Supreme Court Justice, U.S. Senators and Representatives, Governors, educators, civil rights leaders, journalists, authors, and an athlete.

QUALIFICATIONS

The 2023-2024 NEA priorities focus on advancing Racial Justice in Education, increasing educator voice, engaging new and early career Educators, supporting professional excellence, and securing a pro-public education environment. In alignment with these goals, a duly nominated individual, organization or group shall have significantly contributed to the advancement of public education through exhibited leadership, acts, and support of education on a national level, that establishes the nominee as a friend of education, education employees, and/or students. A nominee doesn't have to be an American citizen, but should reflect philosophies and principles that advance NEA's mission, priorities, and strategic goals.

NOMINATIONS

Any member of the National Education Association or any local or state affiliate of NEA may nominate an individual, organization or group to the Friend of Education Award Committee by completing a nomination form and submitting it to the NEA by **January 2, 2024**. Each nomination must be signed and submitted by an NEA member. Non-NEA members are not eligible as nominators.

SELECTION OF RECIPIENT

The Friend of Education Award Committee, composed of six members of the NEA Board of Directors, will review each duly submitted nomination and recommend a recipient to the NEA Board of Directors for approval.

PRESENTATION

The presentation of the Friend of Education Award is a scheduled event at the annual NEA Representative Assembly, and is made to the award recipient by the NEA President.

SUBMISSION DEADLINE

The deadline for receiving nominations for the 2024 NEA Friend of Education Award is January 2, 2024. Nominations must be signed and include proof of the nominator's NEA membership or affiliation. Friend of Ed timeline notification sent to State Presidents and Board of Directors.

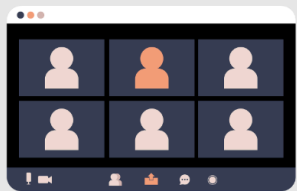


Applications
